Advertising costs, if warranted, may be deducted from the gross proceeds of the auction, payable by the seller.

SELLER will provide a complete description of all items to be sold including serial numbers. All information, including sale prices, may appear in advertising/marketing.	
SELLER will deliver all items (and titles) to RepoMax no later than 14 DAYS prior to the auction date. Items must be in the cleanest, most functional condition possible. Misrepresentation of information provided by the SELLER shall not be held against RepoMax in any circumstance.	
SELLER guarantees that all titled items possess a good and legal title and that they have authorization to sell the item at auction. SELLER also guarantees that items are without mortgages, liens or encumbrances of any kind except those that are specifically detailed in the contract. SELLER will maintain necessary insurance until payment processes are complete. Please list any creditor and/or lien balance on back. Title processing fees will be \$10 per titled unit.	
SELLER holds RepoMax harmless from any damage or liability claims resulting from involvement of with the item(s). SELLER will be liable for any theft, damage, fire or vandalism that may occur while item is on the auction premises or while being handled by RepoMax. SELLER will assume all attorneys' fees and court costs if a case should arise from auctioning their item.
